The Government of Nepal, Ministry of Communication and Information Technology and Film Development Board has allocated funds towards the cost for **Construction of Indoor Film Studio at Banepa Municipality, ward no 10 & 13, Kavrepalanchowk** and intends to apply part of the funds to cover eligible payments under the contract for **Construction of Indoor Film Studio**. Bidding is open to all eligible Nepalese bidders.

The **Film Development Board** invites **Electronic bids** under **NCB-Single Stage Two Envelope Bidding** procedures from eligible bidders for the **Construction of Indoor Film Studio at Banepa Municipality, ward no 10 & 13, Kavrepalanchowk** as in accordance with **e-GP Procurement Directive 2080**. Eligible bidders with the following key qualifications should participate in this bidding and may obtain further information and inspect the Bidding Documents through PPMO website www.bolpatra.gov.np/egp

Key qualifications:

- a) Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: **NRs. 13,04,28,000.00 (excluding VAT)**
 - b) Minimum Work experience of similar size and nature: **Construction of one number building project within last 10 years with value of NRs. 5,21,71,000.00 (excluding VAT)**
 - c) The bidding capacity of the bidder should be equal to or more than the **NRs. 8,69,52,000.00 (excluding VAT)**
